<b>Number of People Self-Directing</b>	<ul style="list-style-type: none"> <li>• OCDD: 1,796 people</li> <li>• OAAS: 197 people</li> </ul>
<b>Funding Source</b>	<ul style="list-style-type: none"> <li>• OCDD: Four 1915(c) Home and Community Based Waivers</li> <li>• OAAS: Two 1915(c) Home and Community Based Waivers</li> </ul>
<b>Agent</b>	Two State-Wide Fiscal Employer Agencies to choose from
<b>Authority</b>	<ul style="list-style-type: none"> <li>• OCDD: Employer authority (with plans to shift to budget authority)</li> <li>• OAAS: Budget authority</li> </ul>
<b>Hiring Restrictions</b>	<ul style="list-style-type: none"> <li>• Same guidelines as workers with traditional providers</li> <li>• Cannot be “Authorized Representative” and Paid Direct Support Worker for person in Self-Direction</li> </ul>
